BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the petition of TECHBILT HOMES, INC., a California corporation, contained in Document No. 730777, for the formation of a maintenance district to provide for the operation and maintenance of ornamental street lighting systems and landscaping under the provisions of the San Diego Maintenance District Procedural Ordinance of 1969, is hereby accepted.

That the City Engineer be, and he is hereby directed to prepare plans, drawings, typical cross-sections, profiles and specifications for the above-described improvement in the subdivision to be known as LA JOLLA ALTA, in the City of San Diego, together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district and a plat showing the exterior boundaries of the district to be included in the assessment for the work and improvement hereinabove mentioned.
