

RESOLUTION NO. 199443

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That an easement for the purpose of a right of way for
a public sewer and appurtenances thereto, through, over, under,
along and across the hereinafter described property, be, and
the same is hereby set aside for such public purposes:

All that portion of Pueblo Lot 1787 of
the Pueblo Lands of San Diego, according
to Map thereof made by James Pascoe in
1870, a copy of which said Map was filed
in the office of the Recorder of San Diego
County as Miscellaneous Map No. 36, on
November 14, 1921, being a strip of land
15.00 feet in width, lying 7.50 feet on
each side of the following described
centerline:

Commencing at the Northwesterly corner of
Lot 319, Harborview Heights Unit No. 5,
according to Map thereof No. 5815, filed
on January 12, 1967 in said Recorder's
office; thence South 75°42'05" West, a
distance of 549.16 feet; thence South
25°44'22" East, 71.31 feet to the TRUE
POINT OF BEGINNING; thence South
48°17'00" West, 11.09 feet; thence
South 66°12'50" West, 85.72 feet to a
terminus in an intersection with the
centerline of that certain 20.00 foot
easement for sewer purposes, recorded
October 11, 1962 as File/Page 175670 of
Official Records of the County of San
Diego.

Basis of Bearings: The Westerly line of
Lots 319 to 322, Harborview Heights
Unit No. 5, Map No. 5815, i.e., North
16°47'55" West.

BE IT FURTHER RESOLVED, that the City Clerk is hereby
authorized and directed to file a copy of this resolution in the
office of the County Recorder of San Diego County.
