

RESOLUTION NO. 199444

WHEREAS, The City of San Diego is the owner of an easement for drainage purposes in portions of Lots 2 and 9, Block 19, Rosedale, according to Map thereof No. 826, filed January 21, 1897, in the office of the San Diego County Recorder; and

WHEREAS, said easement has never been used for the purpose for which it was acquired and more than one (1) year has elapsed since the date said easement was acquired; and

WHEREAS, said easement as hereinafter described is unnecessary for present or prospective public use by the City, and the City Manager recommends that the City vacate its interest therein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That, pursuant to Section 50443 of the Government Code of the State of California, the drainage easement more particularly described hereinafter is hereby vacated:


That certain 20.00 foot drain easement described as Parcel 8 in Resolution No. 189280, adopted by the San Diego City Council on January 12, 1967, and filed January 16, 1967 as Document No. 707503, in the office of the City Clerk of San Diego, and recorded January 23, 1967, as File/Page 9363, in the office of the San Diego County Recorder.

That from and after the date of this order of vacation, title to the land previously subject to said drainage easement shall revert to the owner of the land free from the rights of the public.

BE IT FURTHER RESOLVED, that the City Clerk of said City be, and he is hereby authorized and directed to deliver a certified copy of this resolution to the Property Director

of said City for further handling.
