

RESOLUTION No. 199451


Adopted on APR 7 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of EDWIN PARKER, JR., executed in favor of The City of San Diego, bearing date March 2, 1970, conveying to said City an easement and right of way for sewer purposes, through, along and across portions of Acre Lot 26 and Lots 4 to 8 inclusively in Block 8, all in Sorrento Lands and Townsite according to Map thereof No. 483, filed in the office of the County Recorder of San Diego County, February 19, 1888, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director, be, and the same is hereby approved.

That the City Clerk of said City is hereby authorized and directed to transmit the foregoing said deed to the Property Department for recording and further disposition.


