

RESOLUTION No. 199453


Adopted on APR 7 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of JOHN C. ROE and M. E. ROE, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date January 23, 1970, conveying to said City an easement and right of way for sewer purposes, through, along and across a portion of the West Half of the Southeast Quarter of the Northeast Quarter of Pueblo Lot 1307 Pueblo Lands of San Diego, according to Map thereof made by James Pascoe in the year 1870, a copy of which said Map was filed November 14, 1921 in the office of the County Recorder of San Diego County, California, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director, be, and the same is hereby approved.

That the City Clerk of said City is hereby authorized and directed to transmit the foregoing said deed to the Property Department for recording and further disposition.


