

RESOLUTION NO. 199456

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, APPROVING THE PLANS AND PROFILES SHOWING THE CONTEMPLATED CHANGES AND MODIFICATIONS IN THE WORK DESCRIBED IN RESOLUTION OF INTENTION NO. 198871 FOR THE IMPROVEMENT OF RUFFNER STREET, OPPORTUNITY ROAD AND ENGINEER ROAD.

WHEREAS, this City Council did on January 13, 1970, adopt the Resolution of Intention No. 198871 and declare its intention to order the construction of certain improvements as more fully described therein and on the plans, profiles and drawings therein referred to, and did provide for the cost of certain work to be assessed against the district described in said Resolution of Intention; and

WHEREAS, the public interest, convenience and necessity require that, (1) certain changes and modifications be made in the proposed work to be done in the said Resolution of Intention, and (2) that said Resolution of Intention be amended by the additional requirement of acquiring a right of way for street dedication in ENGINEER ROAD; and

WHEREAS, said changes so described do not amount to more than twenty per cent of the total estimated cost of the work as determined from the Engineer's estimate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. The plans, drawings, typical cross-sections, profiles and specifications for the improvement of RUFFNER STREET, OPPORTUNITY ROAD and ENGINEER ROAD, heretofore filed in the office of the City Clerk as Document No. 730539 and approved by Resolution No. 198870 be, and the same are amended to conform with City of San Diego Engineering Department Drawings Nos. 14105-1-D through 14105-3-D, filed in the office of the City Clerk with Document No. 731423,

and the same are hereby approved and adopted as the official drawings, typical cross-sections, profiles and specifications for said work and improvement.

2. That Resolution of Intention No. 198871 be amended by the addition of the following paragraph:

That Public Right of Way for street dedication in ENGINEER ROAD is necessary in connection with the improvement, and that the cost of the acquisition, including incidental expenses thereof, be assessed as a part of the cost of such improvement; that said acquisition is more particularly shown on the plans, profiles, drawings, typical cross-sections, and specifications contained in Document No. 731423 on file in the office of the City Clerk of said City; that the cost of such acquisition be advanced from the appropriate fund of The City of San Diego and that such fund shall thereafter be reimbursed from said assessments.
