APPROVING MAP OF AMHERST COLONY SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by BYRL D. PHELPS, Registered Civil Engineer, and entitled "AMHERST COLONY Being a subdivision of portion of the east 151.00 feet of Lot "K" of La Mesa Colony, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 346, filed in the office of the County Recorder of San Diego County, March 8, 1887, together with that portion of the south 10.00 feet of Amherst Street (formerly Ramona Street) vacated and closed to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map.
