

RESOLUTION NO. 199475

APPROVING MAP OF RANCHOS CON VISTAS SUBDIVISION AND
ACCEPTING ON BEHALF OF THE CITY OF SAN DIEGO THE
EASEMENTS AS GRANTED ON THIS MAP WITHIN THIS SUBDI-
VISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by WILLIAM B. RICK, Registered Civil Engineer, and entitled,
"RANCHOS CON VISTAS Being a subdivision of portion of Lot
1290 of the Pueblo Lands of San Diego, in the City of San Diego,
County of San Diego, State of California, according to Map
thereof made by James Pascoe in 1870, a copy of which said map
was filed in the office of the County Recorder of San Diego
County, November 14, 1921, and is known as Miscellaneous Map
No. 36.", is made in the manner and form prescribed by law and
conforms to the surrounding surveys; that said map and the sub-
division of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts
on behalf of The City of San Diego the negative easements
granted on this map, subject to the conditions set forth thereon,
and the easements with the right of ingress and egress for the
construction and maintenance of sewer, water, drainage and
general utilities as granted on said map and subject to the
conditions set forth thereon.

The Clerk of said City is hereby authorized and directed
to endorse upon said map, as and for the act of the Council,
that said Council has approved said subdivision map and that
those certain negative easements, together with the easements
with the right of ingress and egress for the construction and
maintenance of sewer, water, drainage and general utilities all
as granted and shown on this map within this subdivision, are

accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
