The City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of City, an agreement with TECH-BILT, INC., a California corporation, for the construction of improvements on Soledad Mountain Road within the limits of this subdivision, a distance of approximately 345 feet, in LA JOLLA HARBOUR HEIGHTS subdivision, and to provide for reimbursement by the City, out of Gas Tax Fund 219, in an amount not to exceed \$2,095.00, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 731504.




