The City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of City, an agreement with RANCHO BERNARDO HOMES, INC., a California corporation, for the construction of improvements on West Bernardo Drive, between the northerly line of Rancho Bernardo Road and the subdivision boundary of Westwood Unit No. 2, in WESTWOOD UNIT NOS. 1 and 2 subdivisions, and to provide for reimbursement by the City, out of Gas Tax Fund 219, in an amount not to exceed \$10,575.07, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 731506.
