BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That an easement for the purpose of a right of way for a public street (roadway) and incidents thereto, through, over, under, along and across the hereinafter described property be, and the same is hereby set aside and dedicated as and for a public street and the same is hereby named CAROLINA LANE:

> All that portion of Lot 29, Horton's Purchase, according to Map thereof No. 283, filed on the 9th of March 1878, in the office of the Recorder of the County of San Diego, further described as follows:

Commencing at the Southwest corner of said Lot 29; thence North 89°59'50" East, along the center line of HILLTOP DRIVE (as shown on City Engineer's Drawing No. 6877-B), 361.26 feet; thence North 00°00'50" East (Record, per Deed of Dedication accepted by Resolution 166805, July 16, 1961, North 00°01'05" East), 30.00 feet to the TRUE POINT OF BEGINNING; thence continuing North 00°00'50" East, 633.28 feet (Record North 00°01'05" East, 633.60 feet) to a point in the Northerly line of the Southerly half of said Lot 29; thence South 89°56'50" West (Record North 89°38'45" West), a distance of 1.00 foot; thence South 00°00'50" West, a distance of 633.28 feet (Record South 00°01'05" West, 633.60 feet) to an intersection with the Northerly line of Hilltop Drive, as shown on said Drawing No. 6877-B; thence North 89°59'50" East, a distance of 1.00 foot, returning to said TRUE POINT OF BEGINNING.
