That an easement for the purpose of a right of way for a public street (roadway) and incidents thereto, through, over, under, along and across the hereinafter described property be, and the same is hereby set aside and dedicated as and for a public street and the same is hereby named ILEX AVENUE:

All that portion of Lot 2, Imperial Manor Unit No. 2, according to Map thereof No. 6544, filed on the 19th of November 1969, in the office of the Recorder of the County of San Diego further described as follows:

Commencing at the Northwesterly corner of said Lot 2 (being also the Northeasterly corner of Imperial Manor Unit No. 1, Map No. 6391); thence South 00°36'03" West, along the subdivision boundary line common to Map No. 6391 and Map No. 6544, a distance of 30.00 feet to an intersection with a point in the Southerly boundary of that certain parcel of land, dedicated for Ilex Avenue on said Map No. 6544; thence South 89°20'47" East along said Southerly boundary, a distance of 426.07 feet to the beginning of a tangent 120.00 foot radius curve, concave Southwesterly; thence Southeasterly along the arc of said curve through a central angle of 29°53'07", an arc length of 62.59 feet; thence tangent to said curve, South 59°27'40" East, a distance of 8.70 feet to a point of cusp and the beginning of a 115.00 foot radius curve, concave Southwesterly; thence Northwesterly and Westerly along the arc of said curve through a central angle of 29°53'07", an arc length of 59.98 feet; thence tangent to said curve, North 89°20'47" West along a line which is parallel with and distant 5.00 feet Southerly, measured at right angles from that certain line described above as having a length of 426.07 feet and a bearing of South 89°20'47" East, a distance of 436.10 feet to an intersection with the Westerly line of said Lot 2; thence North 00°36'03" East along said Westerly line, a distance of 5.00 feet returning to said TRUE POINT OF BEGINNING.
