

RESOLUTION No. 199490


Adopted on APR 7 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of SWANCO MANAGEMENT COMPANY, a corporation, executed in favor of The City of San Diego, bearing date February 13, 1970, conveying to said City an easement and right of way for sewer purposes, through, along and across portions of Lot 24 and Acre Tracts A and B of Lot 22 of the Sorrento Lands and Townsite according to Maps thereof Nos. 362 and 483, filed in the office of the County Recorder of San Diego County September 30, 1887 and February 9, 1888 respectively, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director, be, and the same is hereby approved.

That the City Clerk of said City is hereby authorized and directed to transmit the foregoing said deed to the Property Department for recording and further disposition.


