

RESOLUTION NO. 199504

APPROVING MAP OF MEADOWBROOK SUBDIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC THE PUBLIC STREETS AND PORTIONS OF PUBLIC STREETS DEDICATED ON SAID MAP, AND ACCEPTING ON BEHALF OF THE CITY OF SAN DIEGO THE EASEMENTS AS GRANTED ON THIS MAP WITHIN THIS SUBDIVISION, AND REJECTING THE OFFER OF DEDICATION FOR PUBLIC USE THOSE AREAS MARKED "RESERVED FOR FUTURE STREET" AS SHOWN ON THIS MAP.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by ROBERT E. YOUNG, Registered Civil Engineer, and entitled "MEADOWBROOK Being a subdivision of a portion of Lot 12 of the Rancho Mission of San Diego, in the City of San Diego, County of San Diego, State of California according to the partition map thereof made in an action entitled "Commercial Bank of San Diego vs. Juan M. Luco et al.," on file in the office of the County Clerk of said San Diego County.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the public streets and portions of public streets to wit: ~~Black Oak Road,~~ ~~Brutus Street,~~ ~~Gloaming Avenue,~~ ~~Lausanne Drive,~~ ~~San Vicente Street,~~ portion of ~~Meadowbrook Drive~~ and portion of ~~Siena Street~~ for public purposes, and said streets and portions of streets are hereby declared to be public streets and portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that the said Council hereby accepts on behalf of THE CITY OF SAN DIEGO, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities, as granted and shown on said map, and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council rejects as dedications for public streets Lot A and Lot B each of this subdivision marked "Reserved for Future Street" as shown on this map, under the provisions of Section 11616 of the Business and Professions Code.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portions of public streets are accepted on behalf of the public as heretofore stated; and that those certain easements with the right of ingress and egress for the construction and maintenance of sewer, water and drainage facilities as granted and shown on this map within this subdivision, are accepted on behalf of THE CITY OF SAN DIEGO, a municipal corporation, as above stated; and said Council has rejected on behalf of the public Lot A and Lot B marked "Reserved for Future Street" shown on this map within this subdivision, all as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
