

RESOLUTION No. 199523

BE IT RESOLVED, by the Council of The City of San Diego as follows:

The acceptance by the City Manager of the Quitclaim Deed of RANCHO BERNARDO HOMES, INC., a corporation, 12425 Rancho Bernardo Road, San Diego, California 92128, executed the 18th day of March 1970, relinquishing to THE CITY OF SAN DIEGO all right, title and interest in and to all water mains and appurtenant structures and all sewer lines and appurtenant structures constructed for its use, located in public streets, rights-of-way, highways and public places either within or without the subdivision named BERNARDO VILLAGE GREEN UNIT NO. 1, Map No. 5579, all as more particularly described in said deed, valued at \$500 or more, be, and the same is hereby approved.

The Clerk of said City be, and he is hereby authorized and directed to certify and file said instrument for record in the office of said County Recorder.
