

RESOLUTION NO. 199529

WHEREAS, in connection with the filing of the subdivision to be known as SUN COUNTRY SUBDIVISION, Tentative Map No. 68-100, the developer thereof, Wm. Lyon Development Co., Inc., a corporation, has applied to the Council for a waiver of the underground electrical lines requirement of Section 102.0221, paragraph 7, of the San Diego Municipal Code; and

WHEREAS, the Council has determined to waive said underground electrical lines requirement along San Diego Mission Road upon conditions and terms as set forth in the agreement on file in the office of the City Clerk as Document No. 731845; and

WHEREAS, the Council should authorize the City Manager to execute said agreement and provide for its recordation in the office of the Recorder of San Diego County; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The City Manager be, and he is hereby authorized to execute, for and on behalf of The City of San Diego that certain agreement with Wm. Lyon Development Co., Inc., a corporation, on file in the office of the City Clerk as Document No. 731845.

2. The City Clerk be, and he is hereby authorized and directed to record in the office of the Recorder of San Diego County this resolution and the aforementioned agreement with Wm. Lyon Development Co., Inc., affecting the subdivision to be known as SUN COUNTRY SUBDIVISION, located southeasterly of Ward Road and San Diego Mission Road, in the A-1-10 Zone (R-3 upon filing of map).
