

RESOLUTION NO. 199550

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That an easement for the purpose of a right of way for a public street (roadway) and incidents thereto, through, over, under, along and across the hereinafter described property be, and the same is hereby set aside and dedicated as and for a public street and the same is hereby named 15TH STREET:

All that portion of Lot 1, Nazarene Park, according to Map thereof No. 4448, filed on the 20th day of January 1960, in the office of the Recorder of San Diego County, further described as:

Commencing at the Southwesterly corner of said Lot 1; thence North $89^{\circ}43'53''$ East (Map No. 4448), along the Southerly boundary of said Lot 1, a distance of 177.46 feet to the TRUE POINT OF BEGINNING; thence North $00^{\circ}08'52''$ West (Map No. 4448), a distance of 105.17 feet to the beginning of a tangent 20.00 foot radius curve, concave Southwesterly; thence Northerly and Northwesterly along the arc of said curve through a central angle of $90^{\circ}00'00''$ (Record $90^{\circ}07'15''$, Map No. 4448), a distance of 31.46 feet (Map No. 4448), to a point in the Northerly boundary of said Lot 1, which is distant thereon, North $89^{\circ}43'53''$ East, 152.05 feet from the Northwesterly corner of Lot 1, being also a point of cusp and the beginning of a tangent 20.00 foot radius curve, concave Southwesterly; thence Easterly and Southeasterly along the arc of said curve through a central angle of $90^{\circ}00'00''$, an arc length of 31.46 feet; thence South $00^{\circ}08'52''$ East, 105.07 feet to the Southerly boundary of said Lot 1; thence North $89^{\circ}43'53''$ East (Map No. 4448), 5.68 feet, returning to said TRUE POINT OF BEGINNING.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to file the foregoing said Resolution in the office of the Recorder of San Diego County.
