King	PUBLIC WORKS DEPARTMENT Sanitation Division	\$80	The suggester proposed that the two trucks used for refuse collection in the South Bay area be given walkie-talkie sets for intercommunication. When help is needed on one route or the other, or there is a breakdown, etc. the time of the crews is saved and extra travel for the trucks is reduced. A trial of this method shows a net saving of about \$800 a year.
Richard J. Jansen	POLICE DEPARTMENT	\$55	It was suggested that instead of the metal bicycle licenses that are applied with a metal strap, a thin adhesive license be used. These are now in use and it is estimated that \$540 a year will be saved in the cost of the 20,000 bicycle licenses used.
Russell S. Giles	POLICE DEPARTMENT	\$10	This officer assigned to school safety work devised a special visual demonstration of pedestrian and bicycle dangers. This effective demonstration has been adopted by the Police Department for wide use. It is a good community relations performance.
