

RESOLUTION NO. 199572

WHEREAS, the Council of The City of San Diego has by Resolution No. 198715 reversed the action of the Planning Commission in granting an amendment to Conditional Use Permit No. 6753 to retain those certain converted garages located at 4414, 4415, 4416, 4503, 4606, 4214, 4225, 4411, 4309, 4220 and 4211 Collwood Lane, all constructed on Lots 1 and 2 of Collwood Glen in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 5772 filed in the office of the County Recorder of San Diego County on August 18, 1966; and

WHEREAS, it is in the public interest that a period of time be granted for the reconversion of the subject garages; and

WHEREAS, the Council of The City of San Diego has by Resolution No. 198718 granted a period of 40 months in which to effect the reconversion; and

WHEREAS, the legal description in said resolution was insufficient to provide constructive notice to any person acquiring title to one of the condominium units affected; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The converted garages or carports shall be restored to the original configuration as set forth in the original plans for Collwood Glen, such restoration to be completed no later than 40 months from December 18, 1969, or prior to the sale of the individual premises, whichever shall first occur.

2. Resolution No. 198718, adopted December 18, 1969 be, and it is hereby rescinded.

3. The Clerk of said City be, and he is hereby authorized and directed to certify and file a copy of this resolution for record in the office of the County Recorder of San Diego County.
