

RESOLUTION NO. 199581

WHEREAS, in accordance with the provisions of San Diego Municipal Code Section 101.1002, building permit applications for (1) a sign, and (2) a telephone booth at 2308 San Diego Avenue submitted by Dwaine E. Carlson, dba King Size Ole Restaurant, were referred to the Old San Diego Architectural Control Board for review and approval; and

WHEREAS, these premises are within the boundaries of the Old San Diego District as defined in San Diego Municipal Code Section 101.1001 and subject to the jurisdiction of the Architectural Control Board as provided in San Diego Municipal Code Section 101.1000 to 101.1008; and

WHEREAS, at its meeting on March 17, 1970 the Architectural Control Board reviewed these permit applications and rendered its unanimous decision to disapprove issuance of both permits based on the following:

1. In the case of the sign the Architectural Control Board found that it did not conform to the architectural standards for signs pursuant to San Diego Municipal Code Section 101.1004 in that the area exceeds the maximum display area allowed; and

2. In the case of the telephone booth the Architectural Control Board found that it did not conform in either its design or materials used as specified in the Board's duly adopted Criteria for Evaluation as stated in Resolution No. 191556;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the appeal of DWAIN E. CARLSON, dba King Size Ole Restaurant, as to each permit is hereby denied.

2. That the decision of the Architectural Control Board and the findings of fact upon which said decision was based are hereby affirmed.
