

RESOLUTION NO. 199582

WHEREAS, in accordance with the provisions of San Diego Municipal Code Section 101.1002, a building permit application for a roof sign at 4200 Taylor Street submitted by Padre Trails Inn, Ltd. was referred to the Old San Diego Architectural Control Board for review and approval; and

WHEREAS, these premises are within the boundaries of the Old San Diego District as defined in San Diego Municipal Code Section 101.1001 and subject to the jurisdiction of the Architectural Control Board as provided in San Diego Municipal Code Section 101.1000 to 101.1008; and

WHEREAS, at its meeting on March 17, 1970 the Architectural Control Board reviewed this permit application and rendered its unanimous decision to disapprove issuance of the permit because the Board found that the sign construction proposed did not conform to the architectural standards for signs pursuant to San Diego Municipal Code Section 101.1004 in that the display area exceeds the maximum allowed and the sign projects above the highest point of the roof line of the supporting building; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the appeal of PADRE TRAILS INN, LTD. is hereby denied.
2. That the decision of the Architectural Control Board and the findings of fact upon which said decision was based are hereby affirmed.
