

RESOLUTION NO. 199596

WHEREAS, heretofore by deed recorded July 25, 1941, in Book 1208 at Page 395 of Official Records of the San Diego County Recorder, The City of San Diego acquired an easement for sewer purposes affecting a portion of Lot 1 of Handley Tract; and

WHEREAS, said easement has never been used for the purpose for which it was acquired and more than one (1) year has elapsed since the date said easement was acquired; and

WHEREAS, said easement as hereinafter described is unnecessary for present or prospective public use by the City, and the City Manager recommends that the City vacate its interest therein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That, pursuant to Section 50443 of the Government Code of the State of California, the sewer easement more particularly described hereinafter is hereby vacated:

That certain easement for sewer purposes granted to The City of San Diego by document recorded in the office of the San Diego County Recorder on July 25, 1941 in Book 1208, Page 395 of Official Records, lying within Lot 1 of Handley Tract, according to Map thereof No. 6484, filed in the office of said San Diego County Recorder.


That from and after the date of this order of vacation, title to the land previously subject to said sewer easement shall revert to the owner of the land free from the rights of the public.

BE IT FURTHER RESOLVED, that the City Clerk of said City be, and he is hereby authorized and directed to cause a certified copy of this resolution, attested by him under

seal, to be delivered to the Property Director of said City for further handling.
