

RESOLUTION NO. 199599

APPROVING MAP OF LARWIN MESA VIEW UNIT NO. 2 SUB-DIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC THE PUBLIC STREETS DEDICATED ON SAID MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by GARY L. McCABE, Registered Civil Engineer, and entitled, "LARWIN MESA VIEW UNIT NO. 2 Being a subdivision of a portion of Lot 4 and the Southeast Quarter of the Southwest Quarter of Section 30, Township 14 South, Range 2 West, San Bernardino Meridian according to United States Government survey approved November 19, 1880 and a portion of the Southeast Quarter of the Southeast Quarter of Section 25, Township 14 South, Range 3 West, San Bernardino Meridian, according to United States Government survey approved August 14, 1876, all being in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the public streets, to wit:
~~Westonhill Drive, Libra Drive, Bootes Street, Polaris Drive, Andromeda Road and Canis Lane~~ for public purposes and said streets are hereby declared to be public streets and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
