


# RESOLUTION No. 199603

1. That the bid of \$165,600.70 by Parkway Plumbing Company, Inc., A Corporation, for the DEVELOPMENT OF OLIVE GROVE PARK AND RECREATION CENTER in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 730478.
  
2. That the expenditure of \$199,600.00 is hereby authorized out of the Park and Recreation Bond Fund (725) of the City of San Diego solely and exclusively for the purpose of providing funds for DEVELOPMENT OF OLIVE GROVE PARK AND RECREATION CENTER in the City of San Diego, and related costs.






