

RESOLUTION No. 199605


Adopted on APR 28 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$114,697.03 by Long, Marker & Howley Construction Co., a corporation, for THE CONSTRUCTION OF EAST MOUNTAIN VIEW WATER MAINS in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 730840.

2. That the expenditure of \$171,000.00 is hereby authorized out of the Water Revenue Fund 502 of the City of San Diego solely and exclusively for the purpose of providing funds for THE CONSTRUCTION OF EAST MOUNTAIN VIEW WATER MAINS in the City of San Diego, and related costs.


