

RESOLUTION NO. 199621

APPROVING MAP OF CORONADO TERRACE UNIT NO. 1 SUB-DIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC PORTIONS OF PUBLIC STREETS DEDICATED ON SAID MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, Registered Civil Engineer, and entitled, "CORONADO TERRACE UNIT NO. 1 Being a subdivision of Lots 50, 51, 52, 53, and 56, and portions of Lots 49, 57, 58, 59, 60, 61, and 64 of Nestor Acres, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 1768, filed in the office of County Recorder of San Diego County, November 21, 1923.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, portions of public streets, to wit: portion of ~~25th~~ Street and portion of ~~Coronado~~ Avenue, for public purposes, and said portions of streets are hereby declared to be portions of public streets and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portions of public streets are accepted on behalf of the public as heretofore stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
