

RESOLUTION NO. 199651

WHEREAS, an appeal was filed by James A. Morgan from a decision by a Police Department Hearing Officer to deny a movie theater license at 1063 University Avenue, which decision, pursuant to notice and hearing on April 3, 1970, was based on the following grounds:

1. That the place of location is not suitable for the particular business; and
2. That the business would be used to promote illegal activity; and

WHEREAS, Mr. Morgan was properly notified that the City Council would hear his appeal at its regular meeting on the 28th day of April 1970; and

WHEREAS, Mr. Morgan and a representative of the Chief of Police appeared before the Council to argue their respective cases based on the evidence presented to the Police Department Hearing Officer; and

WHEREAS, it was the decision of the Council to deny Mr. Morgan's appeal; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the appeal of Mr. James W. Morgan is denied and the movie theater license for the premises at 1063 University Avenue shall not issue as recommended by the Chief of Police.
