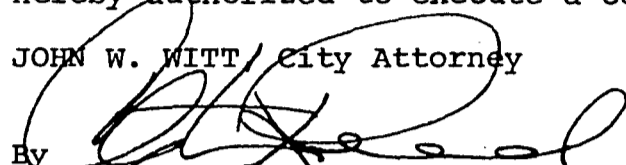
RESOLUTION No. 199658

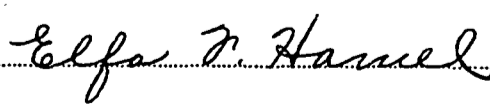

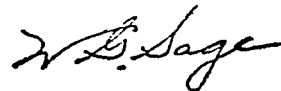
