

RESOLUTION NO. 199668

APPROVING MAP OF SUN COUNTRY SUBDIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC THE PORTIONS OF PUBLIC STREETS DEDICATED ON SAID MAP, AND ACCEPTING ON BEHALF OF THE CITY OF SAN DIEGO THE EASEMENT AS GRANTED ON THIS MAP WITHIN THIS SUBDIVISION, AND REJECTING THE OFFER OF DEDICATION FOR PUBLIC USE THAT PORTION MARKED "RESERVED FOR FUTURE STREET" AS SHOWN ON THIS MAP.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by THOMAS S. W. WONG, Registered Civil Engineer, and entitled, "SUN COUNTRY SUBDIVISION Being a subdivision of portions of Lots 39 and 40 of Township 16 South, Range 2 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, being Tract No. 1, "Buildings," Tract No. 2, "Garden," and Tract No. 3, "Olive Orchard" respectively, of the Ex-Mission San Diego, finally confirmed to Joseph Sadoc Alemany, Roman Catholic Bishop of Monterey, and described in patent from United States of America to said Bishop, recorded in Book 1, page 28 of Patents, in the office of County Recorder of San Diego County, and as shown on Plat of said Award, approved January 14, 1861, and on file in the office of the United States Surveyor. Also Lot 48 of the partition of the Rancho Ex-Mission of San Diego, in the City of San Diego, County of San Diego, State of California, according to Partition Map thereof on file in the office of the County Clerk of said County in action No. 348 in the Superior Court, entitled 'Juan M. Luco, et al, vs., The Commercial Bank of San Diego, et al'." is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the portions of public streets, to wit: portion of San Diego Mission Road and portion of Rancho Mission Road, for public purposes,

and said portions of streets are hereby declared to be portions of public streets, and dedicated to the public use.

BE IT FURTHER RESOLVED, that the said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of sewerage facilities, as granted and shown on said map, and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council rejects as a dedication for public street that portion of Parcel "A" marked "Reserved for Future Street" as shown on this map, under the provisions of Section 11616 of the Business and Professions Code.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portions of public streets are hereby accepted on behalf of the public as heretofore stated; and that that certain easement with the right of ingress and egress for the construction and maintenance of sewerage facilities as granted and shown on this map within this subdivision is accepted on behalf of The City of San Diego, a municipal corporation, as above stated; and said Council has rejected on behalf of the public that portion of Parcel "A" marked "Reserved for Future Street" shown on this map within this subdivision, all as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
