

RESOLUTION NO. 199673

WHEREAS, The City of San Diego has been advised by the Director of Public Works of the State of California that its apportionment of funds under the Federal Aid TOPICS Program is \$798,666.00 for Fiscal Year 1969-70, as provided by Chapter I of Title 23, United States Code; and

WHEREAS, prior to June 30, 1970, The City of San Diego is required to indicate its intent to use said funds; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That TOPICS funds apportioned for Fiscal Year 1969-70 shall be expended for improvement projects to be subsequently identified.

2. That TOPICS funds apportioned for Fiscal Year 1969-70 will be accumulated and combined with funds to be apportioned for Fiscal Year 1970-71 in order to finance a larger project.
