

RESOLUTION NO. 199674

WHEREAS, Charles Stackfield is the owner of certain real property and improvements located at 2835 L Street, San Diego, California, and more particularly described as follows:

Reed's Central Addition, Lot 11
and East Half of Lot 12, Block 2,
Map 981;

and

WHEREAS, said real property has been improved with a certain building situate thereon; and

WHEREAS, said building has been found by the Building Inspection Director to be substandard and has been found to constitute a hazard to public safety, health and welfare by reason of inadequate maintenance, dilapidation and fire hazard; and

WHEREAS, the owner of the above-described property was notified by letter from the Building Inspection Director, dated November 13, 1969, of these findings; and

WHEREAS, on February 25, 1970, at a public hearing, the Housing Advisory and Appeals Board approved said findings;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The building situate on the property described above is declared to be a public nuisance.
2. The City Attorney is authorized and instructed to take appropriate legal action to abate the aforesaid nuisance.
