

RESOLUTION No. 199695

Adopted on MAY 5 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the petition contained in Document No. 731420 for the construction of certain improvements under the provisions of the Improvement Act of 1911, is hereby granted.

That the City Engineer be, and he is hereby directed to prepare plans, drawings, typical cross-sections, profiles and specifications for grading and paving, as required, as an alley section, the ALLEY, BLOCK F, CONGRESS HEIGHTS UNIT NO. 2, in the City of San Diego, together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district and a plat showing the exterior boundaries of the district to be included in the assessment for the work and improvement hereinabove mentioned.
