

RESOLUTION OF INTENTION NO. 199697

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS
OF THE STREET VACATION ACT OF 1941, DECLARING THE
INTENTION OF THE CITY COUNCIL TO VACATE

PORTIONS OF LA AMATISTA ROAD, CONDESA
DRIVE AND 8TH STREET,

AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, By the Council of The City of San Diego,
that the public interest and convenience of said City require
the vacation of a portion of the street hereinafter mentioned;
and

BE IT FURTHER RESOLVED, that it is the intention of said
Council to order the vacation of

the Northerly 22 feet of LA AMATISTA ROAD between Condesa Drive
and the south line; the Easterly 23 feet of CONDESA DRIVE between
La Amatista Road and the south line; and the Southerly 10 feet of
8TH STREET (Road Survey 1009) being also the Southerly 10 feet of
the Northerly 60 feet of the Westerly 400 feet; all in the North
1/2 of the Southeast 1/4 of the Southeast 1/4 of Section 14, T14S,
R4W, SBBM,

as more particularly shown on Map No. 12231-B, on file in
the office of the City Clerk as Document No. 731785.

The Council hereby elects to proceed, in making said vaca-
tion, under the provisions of the "Street Vacation Act of 1941."

The Council hereby fixes 9:30 A.M., MAY 26 1970 in the
Council Chamber on the twelfth floor of the City Administration
Building, Community Concourse, 202 "C" Street, in said City of
San Diego, as the time and place for hearing all persons interested
in or objecting to the proposed vacation.

That The Daily Transcript, a daily newspaper published and
circulated, and of general circulation, in the said City of
San Diego, be, and it is hereby designated as the newspaper in
which the Street Superintendent of said City shall cause to be
published, in the manner and form required by law, notice of
the passage of this Resolution of Intention, and the said Street
Superintendent is hereby directed to cause notices of the passage
of this resolution to be posted in the manner and form required
by law and to cause a notice similar in substance to be published
in said newspaper in the manner required by law.
