

RESOLUTION NO. 199717

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That an easement for the purpose of a right of way for
a public street (roadway) and incidents thereto, through, over,
under, along and across the hereinafter described property be,
and the same is hereby set aside and dedicated as and for a public
street and the same is hereby named AREY DRIVE:

That portion of the West Half of the East
Half of the Northeast Quarter of Section 26,
Township 18 South, Range 2 West, San Bernardino
Base and Meridian, in the City of San Diego,
County of San Diego, State of California,
more particularly described as follows:

Beginning at the Northwest corner of Fortune
Park Unit No. 5, according to map thereof
No. 6011, filed in the office of the County
Recorder of said San Diego County; thence
North 00°06'50" East a distance of 29.00 feet;
thence North 89°53'10" West, a distance of
682.48 feet; thence South 00°03'33" East a
distance of 29.00 feet; thence South 89°53'10"
East, a distance of 682.39 feet, returning to
the Point of Beginning.

BE IT FURTHER RESOLVED, that the City Clerk is hereby
directed to file a certified copy of this resolution in the
office of the County Recorder of San Diego County.
