RESOLUTION No. 199720


Adopted on MAY 7 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of the CORPORATION OF THE PRESIDING BISHOP OF THE CHURCH OF JESUS CHRIST OF LATTER-DAY SAINTS, a Utah corporation sole, executed in favor of The City of San Diego, bearing date April 7, 1970, conveying to said City an easement and right of way for street purposes through, over and across a portion of Lot 1 of The Church of Jesus Christ of Latter-day Saints, according to Map No. 6543, filed in the office of the Recorder of San Diego County on November 18, 1969, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director, be, and the same is hereby approved; and the land therein conveyed is hereby set aside and dedicated as and for a public street and the same is hereby named 15TH STREET.

That the City Clerk of said City is hereby authorized and directed to transmit the foregoing said deed to the Property Department for recording and further disposition.


