BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City an Agreement with SPRING VALLEY SANITATION DISTRICT to acquire from District additional capacity rights in the Spring Valley Trunk Sewer up to 3.0 million gallons per day (mgd) in increments of 0.6 mgd for the sum of \$57,600.00 per 0.6 mgd increment, under the terms and conditions set forth in the form of Agreement, on file in the office of the City Clerk as Document No. 731902.
