

RESOLUTION No. 199735

Adopted on MAY 12 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of SOUTHERN CALIFORNIA TERRACES, INC., a California corporation, executed in favor of The City of San Diego, bearing date March 23, 1970, conveying to said City an easement and right of way for water main purposes, through, along and across portions of Quarter Sections 56, 74, 75, 76 and 77 of Rancho de la Nacion, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 166, filed in the County Recorder's office of said County on May 11, 1869, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director, be, and the same is hereby approved.

That the City Clerk of said City is hereby authorized and directed to transmit the foregoing said deed to the Property Department for recording and further disposition.
