

RESOLUTION NO. 199740

APPROVING MAP OF BAY TERRACES UNIT NO. 2 AND ACCEPTING ON BEHALF OF THE PUBLIC THE PUBLIC STREETS DEDICATED ON SAID MAP, AND ACCEPTING ON BEHALF OF THE CITY OF SAN DIEGO THE ABUTTERS' RIGHTS OF ACCESS TOGETHER WITH THE EASEMENTS AS GRANTED ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, Registered Civil Engineer, and entitled, "BAY TERRACES UNIT NO. 2 Being a subdivision of portions of Quarter Sections 74 and 75, Rancho de la Nacion, according to Map thereof No. 166, filed in the office of the County Recorder, City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets, to wit: ~~Morton Way, Hedges Way, Allew Way, Annmar Drive, Aristotle Drive, Garmar Way, Garber Avenue, Omega Drive, Parkside Avenue, Parthenon Drive, Sula Way and Sylvy Way~~ for public purposes and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Parkside Avenue adjacent and contiguous to Lots 557 through 562, 570, 571 and 572; in and to State Route 54 adjacent and contiguous to Lots 599, 600, 601, 611, 612, 614 and 615, all as granted and shown on said map.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego the negative easements granted on this map, subject to the conditions set forth thereon, and the easements with the right of ingress and egress for the

construction and maintenance of drainage facilities and general utilities as granted on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that the abutters' rights of access as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated; and that those certain negative easements, together with the easements with the right of ingress and egress for the construction and maintenance of drainage facilities and general utilities all as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
