Said Council hereby finds that that certain map surveyed by LLOYD G. JEFFERIES, Registered Civil Engineer, and entitled, "WESTWOOD TOWNHOUSES UNIT NO. 1 Being a subdivision of a portion of Rancho San Bernardo, in the City of San Diego, County of San Diego, State of California, according to Map thereof filed in the office of the County Recorder of San Diego County, in Book 2, page 462 of Patents.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public street, to wit: Florindo Road, for public purposes, and said street is hereby declared to be public street and dedicated to the public use.
