

RESOLUTION NO. 199763

WHEREAS, The City of San Diego heretofore entered into an agreement with POPLAR INVESTMENT CO., a California corporation, P.O. Box 11095, San Diego, California 92111, to construct certain improvements in PUEBLO VISTA UNIT NO. 4 subdivision, which agreement is filed in the office of the City Clerk as Document No. 698355; and

WHEREAS, in connection with the performance of said agreement, Bond No. 500305 was issued by General Insurance Company of America, Seattle, Washington; and

WHEREAS, Subdivider has not complied with the terms and provisions of said agreement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. POPLAR INVESTMENT CO., a California corporation, is hereby DECLARED TO BE IN DEFAULT of the agreement filed in the office of the City Clerk as Document No. 698355 on April 15, 1966, relating to the improvement of PUEBLO VISTA UNIT NO. 4 subdivision.


2. The City Attorney shall cause notice of this declaration of default to be given to the said POPLAR INVESTMENT CO., and to the said General Insurance Company of America, Seattle, Washington.

3. The City Manager is authorized to complete, or cause to be completed, said public work and improvements in accordance with the terms of said agreement.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to forward a certified copy of this resolution to the County Recorder.
