BE IT RESOLVED, by the Council of The City of San Diego,
as follows:


That an easement for the purpose of a right of way for
a public street (roadway) and incidents thereto, through, over,
under, along and across the hereinafter described property be,
and the same is hereby set aside and dedicated as and for a
public street and the same is hereby named 15TH STREET:

All that portion of the Southerly one-half
of Lot 5, San Diego Park Acres, according to
Map thereof No. 1679, filed on the 4th day of
November 1915 in the office of the Recorder
of the County of San Diego, further described
as follows:

Beginning at the Southeasterly corner of said
Lot 5; thence Northerly along the Easterly
boundary of Lot 5, a distance of 125.00 feet;
thence South $89^{\circ}43'53''$ West along the Southerly
boundary of Lot 1, Nazarene Park, Map No. 4448
(being also the East-West centerline of Lot 5,
Map No. 1679), a distance of 8.07 feet to an
intersection with a line which is parallel with
and distant 8.07 feet Westerly, measured at
right angles from said Easterly boundary of Lot 5;
thence Southerly along said parallel line 27.38
feet to the beginning of a tangent 266.96 foot
radius curve, concave Northwesterly; thence
Southwesterly along the arc of said curve through
a central angle of $10^{\circ}32'06''$, an arc length of
49.09 feet to a point of reverse curvature, being
the beginning of a 266.96 foot radius curve con-
cave Southeasterly; thence Southwesterly and
Southerly along the arc of said curve, through
a central angle of $10^{\circ}32'06''$, an arc length of
49.09 feet to an intersection with the Southerly
boundary of said Lot 5; thence Easterly along
said Southerly boundary, 17.07 feet returning to
said point or place of beginning.

BE IT FURTHER RESOLVED, that the City Clerk is hereby
authorized and directed to file a copy of this resolution in
the office of the County Recorder of San Diego County.
