

RESOLUTION NO. 199788


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

The agreement entered into between DALE BUILDING COMPANY, a corporation, and THE CITY OF SAN DIEGO on April 28, 1970, filed in the office of the City Clerk as Document No. 731774, which agreement provides for the installation of certain public improvements by Dale Building Company in CORONADO TERRACE UNIT NO. 1 subdivision, be amended to substitute as Exhibit C Performance Bond No. 856510, in the amount of \$14,000.00, executed by Dale Building Company as principal, and General Insurance Company of America as surety, for the faithful performance of said agreement.

BE IT FURTHER RESOLVED, that the sum of \$14,000.00 deposited with the City on April 22, 1970, City Engineer's Receipt No. 43179 be, and it is hereby released.
