Said Council hereby finds that that certain map surveyed by W.R. NOTHOMB, Licensed Land Surveyor, and entitled, "PENASQUITOS VIEW UNIT NO. 1 Being a subdivision of a portion of the Rancho los Penasquitos, in the City of San Diego, County of San Diego, State of California, according to Map accompanying the patent to said Rancho, recorded in the office of the County Recorder of said San Diego County in Book 2, page 385 of Patents.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets, to wit: Via del Sud, Calle Abuelito, Calle de los Ninos, Avenida del General, Avenida de la Cantina, Calle Caballeros and Avenida Grande, for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.
