WHEREAS, Manuel J. & Roberta Ramos are the owners of certain real property and improvements located at 4062 Voltaire Street, San Diego, California, and more particularly described as follows:

WHEREAS, said real property has been improved with a certain building situate thereon; and

WHEREAS, said building has been found by the Building Inspection Director to be substandard and has been found to be an unsafe building by reason of structural deficiency and evidence of structural failure; and

WHEREAS, the owners of the above-described property were notified by letter from the Building Inspection Director, dated March 9, 1970, of these findings; and


WHEREAS, on April 8, 1970, at a public hearing, the Housing Advisory and Appeals Board approved said findings;  
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The building situate on the property described above is declared to be a public nuisance.
2. The City Attorney is authorized and instructed to take appropriate legal action to abate the aforesaid nuisance.
