street purposes.


BE IT FURTHER RESOLVED, that the Walkway between

seal, to be recorded in the office of the County Recorder.

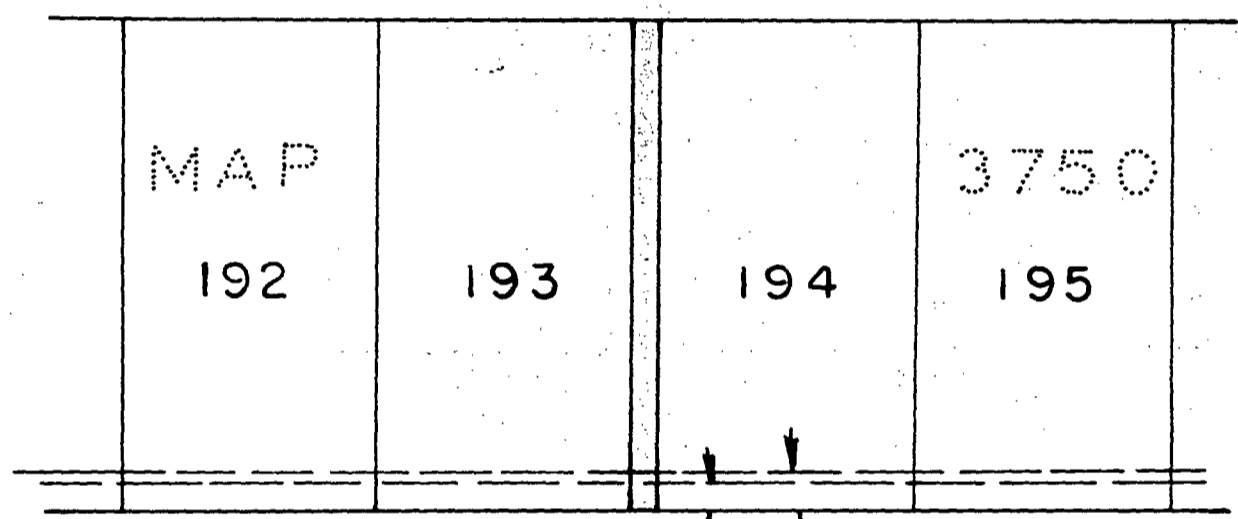
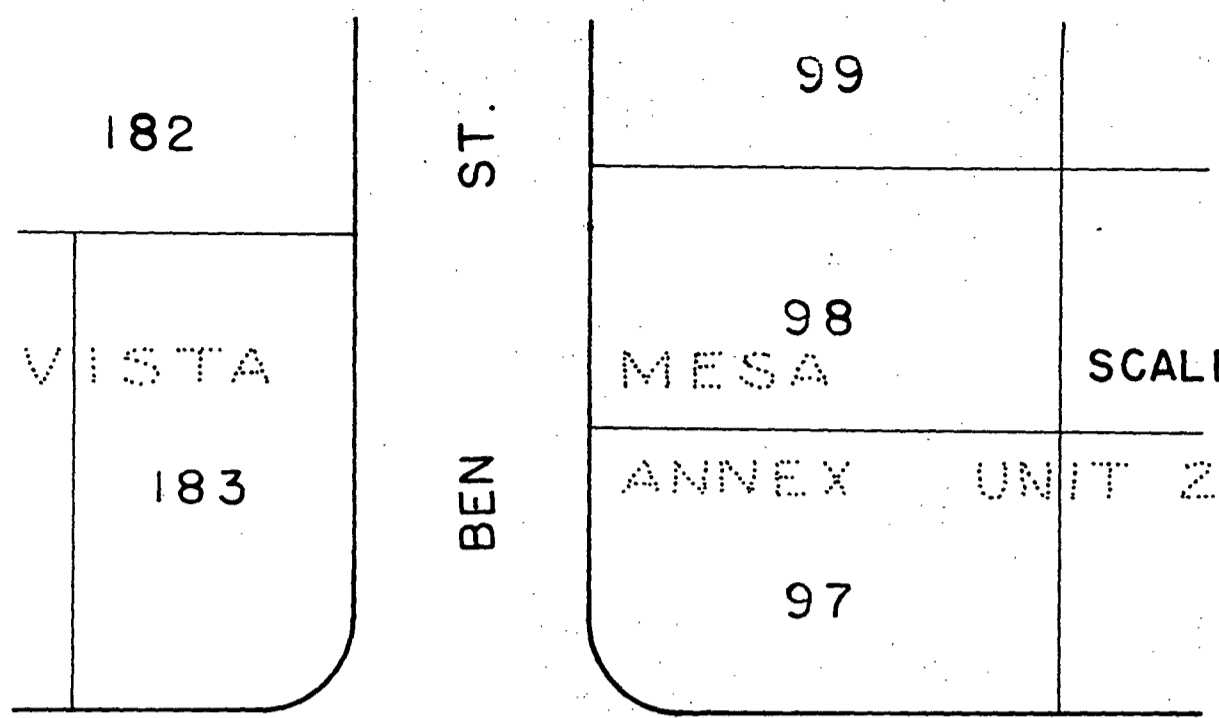
