

RESOLUTION NO. 199830

WHEREAS, Leonard Goldberg, doing business as PHYSICIANS' TRANSPORT SERVICE COMPANY, has applied to the City Council for three Certificates of Public Convenience and Necessity to operate three automobiles for hire within the limits of the City of San Diego; and

WHEREAS, pursuant to Section 72.13 of the San Diego Municipal Code, the City Manager has caused an investigation to be made and has reported his findings in writing to this Council, which report indicates:

- (a) There is a demand from low income and limited financial persons for this service;
- (b) There is no such existing service now operating within the City of San Diego which offers the convenience of this operation at such a low cost;
- (c) The applicant is financially able to provide service of this type without interruption and has been found to be experienced in this field;
- (d) The three types of minibuses to be used have been reviewed by the Police Department and found to meet the requirements of safety standards, as well as the provisions of State and local laws;
- (e) The Traffic Engineer of The City of San Diego reports the minibus operation would not create any additional hazards or traffic problems within the community. Doctors' offices can now qualify for passenger loading zones on an individual basis, and the loading and unloading of patients will not create any problems;

(f) The operation of the three additional vehicles within the City will not result in any greater hazard to the public. The San Diego Transit Corporation has no objection to this operation; and


WHEREAS, the City Council on this date, after a public hearing, has found the contents of the City Manager's report to be direct and accurate; and

WHEREAS, pursuant to Section 72.12 of the San Diego Municipal Code, the Council of the City of San Diego finds that public convenience and necessity require this proposed automobile-for-hire service; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That Leonard Goldberg, doing business as PHYSICIANS' TRANSPORT SERVICE COMPANY at 6066 University Avenue, San Diego, California, having filed an application for three Certificates of Public Convenience and Necessity to operate three vehicles for hire pursuant to the provisions of Section 72.11 of the San Diego Municipal Code, and the City Manager having conducted the required investigation, three Certificates of Public Convenience and Necessity are hereby granted to Leonard Goldberg, doing business as PHYSICIANS' TRANSPORT SERVICE COMPANY, to operate the vehicles specified in the application subject to compliance with all applicable provisions of the San Diego Municipal Code.
