APPROVING MAP OF MIRA MESA VERDE UNIT NO. 11 SUB-DIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC THE PUBLIC STREETS AND PORTIONS OF PUBLIC STREETS DEDICATED ON SAID MAP AND ACCEPTING ON BEHALF OF THE CITY OF SAN DIEGO CERTAIN ABUTTERS' RIGHTS OF ACCESS AS GRANTED ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM J. CLARKE, Licensed Land Surveyor, and entitled, "MIRA MESA VERDE UNIT NO. 11 Being a subdivision of portions of Section 1, Township 15 South, Range 3 West, and Section 36, Township 14 South, Range 3 West, San Bernardino Meridian, in the City of San Diego, County of San Diego, State of California, according to the official Plat thereof.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets and portions of public streets, to wit: Gold Coast Drive, Saluda Avenue, Drumcliff Avenue, Eagle Rock Avenue, Arrow Rock Avenue, Jade Coast Drive, portion of Flanders Drive and portion of San Ramon Drive for public purposes and said streets and portions of streets are hereby declared to be public streets and portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Gold Coast Drive, adjacent and contiguous to Lots 1127, 1170, 1171, 1214, 1215, 1258, 1259 and 1302 and any and all abutters' rights of access in and to Jade Coast Drive, adjacent and contiguous to Lots 1148, 1149, 1192, 1193, 1236, 1237, 1280 and 1281, all as granted and shown on said map.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portions of public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
