William L. Bible Roger L. Becker	PUBLIC WORKS DEPARTMENT Street Division	\$65	Proposed purchase of large, counter-balanced squeegee for silk-screening. Has been found to save time, improve quality, and increase capacity.
Carl E. Mullins	RECREATION DEPARTMENT	\$25	Proposed larger water line so tennis courts can be hosed off more efficiently than hand mopping. Courts available for play much sooner.
Emil J. Kuessel	UTILITIES DEPARTMENT	\$20	Suggester built a trial chlorination station in El Capitan pipe line to demonstrate feasibility of such a system. Stations will now be built in El Capitan and San Vicente lines.
Mary M. Barta	UTILITIES DEPARTMENT	\$15	Suggested discontinuing use of application cards for water service when information is available on the deposit receipt. Saves time and filing space.
James A. Oxe	PUBLIC WORKS DEPARTMENT Equipment Division	\$10	Proposed a change in oil filter adapters so a filter requiring less time to change can be used.
Charles R. Lyons	UTILITIES DEPARTMENT	\$10	Suggested elimination of slipperiness of walkways on digester domes at Point Loma plant.
