

RESOLUTION NO. 199865

APPROVING MAP OF CITY OF SAN DIEGO INDUSTRIAL PARK  
UNIT NO. 7 SUBDIVISION AND ACCEPTING ON BEHALF OF  
THE CITY OF SAN DIEGO THE EASEMENT DEDICATED ON  
THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed  
by THOMAS A. STAMPER, Licensed Land Surveyor, and entitled,  
"CITY OF SAN DIEGO INDUSTRIAL PARK UNIT NO. 7 Being a subdivi-  
sion of Portions of Blocks 19, 22, 23 and 29 of Rosedale, in  
The City of San Diego, County of San Diego, State of California,  
according to Map 826, filed in the Office of the County Recorder  
of said County, January 21, 1897.", is made in the manner and form  
prescribed by law and conforms to the surrounding surveys; that  
said map and the subdivision of land shown thereon is hereby  
approved and accepted.

BE IT FURTHER RESOLVED, that the said Council hereby accepts  
on behalf of The City of San Diego, a municipal corporation, the  
easement with the right of ingress and egress for the construction  
and maintenance of drainage facilities as dedicated and shown  
on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to  
endorse upon said map, as and for the act of the Council that  
said Council has approved said subdivision map and that that  
certain easement with the right of ingress and egress for the  
construction and maintenance of drainage facilities as dedicated  
and shown on this map within this subdivision is accepted on  
behalf of The City of San Diego, a municipal corporation, as  
above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
