

RESOLUTION NO. 199874

WHEREAS, it is the policy of The City of San Diego to preserve its natural environment, eliminate visual nuisances, restore the natural beauty of developed areas and to excel in community design; and

WHEREAS, the City Manager's Office, the Recreation Department and other City departments have worked together to develop an urban beautification program; and

WHEREAS, it is necessary to file such a program known as UB 121, City of San Diego Urban Beautification Program, 1970-71, filed in the office of the City Clerk as Document No. 732064, with the United States Department of Housing and Urban Development in order to obtain matching Federal funds for urban beautification under Title IX of the Housing and Urban Development Act of 1965; and

WHEREAS, this Council is of the opinion that the San Diego Urban Beautification Program for 1970-71, on file in the office of the City Clerk as Document No. 732064, should be adopted in the interest of the public of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the San Diego Urban Beautification Program, 1970-71, be and the same is hereby approved and adopted, and the City Manager is hereby authorized and empowered to forward copies to the Department of Housing and Urban Development of the United States Government.
